Minutes of the Monthly Council Meeting of Lower Halstow Parish Council held in the Memorial Hall at 7.00 pm on Tuesday 1st July 2025.

1. To receive Apologies for absence

Apology was received from Ann Smith, Parish Clerk.

2. To receive any **Declarations of Pecuniary or Non Pecuniary Interest**, and any Applications for Dispensation on Agenda Items. (Requirement of Localism Act 2011.)

Cllr Smith declared a pecuniary interest in items 9a and 9b

3. Public session

A resident wished to express thanks to the Parish Council for enabling the VE 80 event to take place, it was such a lovely evening and everyone that attended enjoyed themselves.

- 4. **Visitors**. Reports or comments from:
- a) KCC

Cllr Palmer wanted to mention that VJ day was the end of World War 2 and seems to be forgotten about, like the forgotten army. Cllr Palmer also wanted to highlight awareness regarding fly tipping, which has cost KCC nearly £5000 in the last few months and causes many road closures. Some local authorities are being more proactive in putting cameras out to aid prosecutions.

Cllr Smith asked if a different teamt could be contacted at KCC Highways. This is regarding the non-existent buffer zones at the entry points to Lower Halstow where the 20mph scheme begins. Cllr Portman reported that the MP had emailed the Cabinet Minister for Transport at KCC asking for an apology and the buffer zone be implemented. There is also a problem outside the school with parking on the pavement on corners and double parking. Bollards have been refused.

b) SBC Councillor

c) Police Officer

d) Friends of the Brickfields.

Fires are being lit on the Brickfields periodically. Cllr Portman has asked the local Police Officer to patrol, but not received a reply.

5. To resolve the Minutes

a) It was resolved that the Minutes of the Monthly Parish Council meeting held on 3rd June 2025 are a correct record and were signed accordingly.

6. Matters Arising

a) It was agreed to offer 16 hours a week to the new Clerk, but with the proviso that this could be negotiated with the successful candidate. The job advert will be placed on the Parish Council website, the Village News and on the Facebook page with a closing date of 31st August. Interviews to be held in September with a view to start October/November.

7. To discuss any planning applications received between producing the agenda and this meeting.

8. Correspondence

a) Two emails from residents in Heron Close regarding trees on the Brickfields close to their property. Cllr Portman visited and the trees are on the Brickfields and they are quite low. They would benefit from crown lifting and maybe height reducing. The Clerk will contact the contractor.

b) Fallen trees on Brickfields blocking a path This has now been cleared. Action: Clerk

9. Finance:

- a) Quotes received for work to Westfield Car Park Cllr Howard-Challis proposed the quote from ATS, seconded by Cllr Szabo and unanimously agreed.
- Quotes received for fencing to Memorial Hall Allotment site.
 Three quotes were requested. Cllr Szabo proposed to accept the quote from ATS, seconded by Cllr Groves and agreed unanimously.

10. Review To receive reports on the following:

- a) Parks & Leisure and Planning Nothing to report on planning. The yearly check is due on the playground, which is looking a little bit sorry for itself. The goal posts have been vandalised causing extensive damage. The nets have been saved. These are being repaired.
- b) Footpaths and Burial Ground There is a damaged drain on the Gibbs amenity area, which Cllr Portman has reported to Southern Water. There have been three white male teenagers with slingshots shooting at animals in the village. They have been reported to the Police. Residents in the village with mobility scooters cannot access some pavements in Lower Halstow due to parked cars. Only one brown bin was emptied this month.
- c) Hedgerow Maintenance
 Cllr Lawrence queried who is responsible for the piece of land next to the Burial Ground;
 it appears that the owners are erecting stables. The crack in the bridge over the sluice in
 Church Path is being measured by Cllr Portman every month. Green Farm House
 footpath is overgrown by Elder and brambles. The wall there has a large crack in it.
- d) Allotments
 There has been some uptake of allotments in the Memorial Hall site. Unfortunately, the vacant plots that were cleared are now overgrown again.
- e) Brickfields and Seawall
 The Friends of the Brickfields submitted two quotes for their signage, there are looking for a donation towards it.

11. Clerk's Report

None. It was agreed that Cllrs Howard-Challis and Szabo would authorise the payments, as per the payment list below, via internet banking.
